There are a couple of additions to the Constitution and By-Law (Revised 1969) in Article II, Section 4 and Article VII, Section 2 as follows:

Article II, Section 4:

The Treasurer shall receive all monies due the Society and shall keep an accurate accounting of such monies and make disbursements as approved by the membership or Board of Directors. He shall submit a full report of the Society's monetary transactions at each regular monthly business meeting. His annual report shall reflect the Society's fiscal year, which shall be December 1 to November 30.

Article VII, Section 2 :

Business meetings shall be held the the first Friday of every month at 10 P.M. at the location specified in Section 1 above. (Art. VII, Sec. 1)
